Gasoline

Brush small quantities (less than a quart) on a board or mix with kitty litter/floor dry in a well-ventilated area, allow to evaporate and then place in the trash.

Herbicides and Pesticides

For household use, buy only what you need. Apply following product instructions. Using more is not better and can contaminate water resources. Disposal options for unwanted product:

Mineral Spirits and Thinners

If you have a small amount, brush onto a board in a well-ventilated area and let evaporate; dispose of board in trash. If useable, give away to someone.

Paint

Oil base paint (mineral spirit cleanup)

- Small amounts can be painted on a board, allowed to dry, and then placed in trash.

Latex paint (water-based cleanup)

- Useable paint to Latex Paint Swap (last Saturday in June) Gallatin Co Fairgrounds.

- Give useable paint to someone to use.
- If paint is not good, dry it out using an absorbent (kitty litter or floor dry) and put in trash.
- Paint newspapers or a board, once dry, put in trash.

Pharmaceuticals (Medications)

Do not flush medications down the drain, toilet or dispose of in the trash. Call local drug take-back program for details:

Photographic Chemicals

If you are connected to a municipal sewer most photographic chemicals can be flushed down the drain followed by lots of water. DO NOT flush selenium toners or solvents. Fixers may be flushed down the drain only after silver recovery. If you are on a septic system, DO NOT flush any photographic chemicals down the drain.

STORAGE AND HANDLING

Properly label and store hazardous chemicals in a cool, dry location away from children and pets until you are ready to properly dispose. For more information about proper household hazardous waste (HHW) disposal, call the Gallatin Local Water Quality District (582-3168).

BOZEMAN CONVENIENCE SITE and the LOGAN LANDFILL DROP-OFF SITE

Bozeman Convenience Site: 2143 Story Mill Rd. HHW drop off is 2nd Saturday of each month 9 am — noon. Free for all county residents. No e-waste or latex paint at this site! For details, call 539-1161.

Logan Landfill Drop-Off Site: Mon—Sat 7:30 am — 4:30 pm. Accepts oil, antifreeze, batteries, propane cylinders.

HIGH RISK HOUSEHOLD HAZARDOUS WASTE

The following products pose an <u>extremely high risk</u> of contaminating our groundwater and surface water if not disposed of properly.

Mercury (thermometers, thermostats, liquid)

<u>NEVER</u> dispose of down the drain or in the trash! For proper disposal contact:

CFLs & Other Fluorescent Bulbs

Contain mercury. **NEVER** break or dispose in trash!

PCBs or PCB Ballasts (polychlorinated biphenyls)

PCBs are oily liquids or solids, colorless to light yellow, and no smell or taste. Used in manufacturing industry, this group of synthetic organic chemicals can cause numerous harmful health effects. Production of PCBs ceased in 1977. Older transformers, old fluorescent light fixtures, TVs, refrigerators, and hydraulic oil may contain PCBs if made before production stopped.

NEVER dispose of down the drain or in the trash!

Chlorinated Solvents

(brake cleaners, spot removers, degreasers, etc.)

These are petrochemicals that are chemically altered. They are extremely toxic, even at low concentrations. Chlorine makes the solvent more stable. That stability means the substance is slow to break down into nontoxic components when discarded. Chlorinated solvents have a high potential to contaminate water supplies. NEVER dispose of down the drain or in the trash! Avoid buying or using products containing "chloro-" in the name (trichloroethylene, perchloroethylene, etc.). Use non-chlorinated solvents instead.

Electronic Waste (computers, TVs, PDAs, etc.)

These contain lead, cadmium, mercury and other heavy metals. NEVER dispose of in the trash!
